Insight from the Daf

Is it prohibited to do business with chodosh? The Mishnah in Shevi'is (7:3) states that one is not permitted to do business with foods that are prohibited. The Rambam rules that one may not do business with any food that is prohibited for consumption even though the food is permitted for benefit. The same ruling is recorded in Shulchan Aruch (YD 117:1). There is a disagreement amongst Poskim whether this prohibition is Biblical or Rabbinic. The Mishnah Lamelech maintains that the prohibition is Biblical whereas the Taz asserts that the prohibition is a Rabbinic injunction instituted out of concern that one who does business with prohibited foods may come to eat those foods. Poskim debate whether this restriction includes chodosh. Do we say that during the time it is prohibited for consumption it is no different than any other prohibited food and one may not do business with it or perhaps since the prohibition is in force for a limited amount of time the restriction does not apply. The Shevet Halevi cites Beis Dovid who rules that outside of Eretz Yisroel there is no prohibition against doing business with chodosh. Since there are those who maintain that the chodosh prohibition does not apply outside of Eretz Yisroel the prohibition against doing business with such a food does not apply as well. The basis of this is a ruling of Pri Chodosh that as long as there are opinions that maintain a food is permitted, the prohibition against doing business with that food does not apply even for those who maintain the food is prohibited. The Shevet Halevi concludes that one should not disparage those who rely upon the position of Beis Dovid.

Something for the Shabbos table

After Avraham was informed that his nephew Lot was taken captive, the Torah tells us that Avraham set out in pursuit of Lot's captors: "He armed his disciples who had been born in his house - three hundred and eighteen - and he pursued them to Dan" (Bereishis 14:14). Rashi cites Chazal who explain that the three hundred and eighteen disciples in reality refer to Avraham's servant Eliezer (אליעזר) whose name has that numerical value. Ray Wolbe points out that it is clear from the ensuing pesukim that there were other people aside from Eliezer who took part in the chase. Nevertheless, Chazal interpreted the number mentioned by the Torah to be referring solely to Eliezer to convey that it was in his merit that they were victorious in battle. In the lens of the Torah, it is the quality not the quantity of the people which is important.

Parenthetically, Ray Wolbe adds that in elections held in a democratic society, the opposite is true: The focus is placed on the quantity and not on the quality of the people voting. The vote of the lawyer well versed in politics carries as much weight as the peasant who never cared to familiarize himself with anything that has to do with the government. The outcome of the elections would be much more politically sound if each person was given voting points according to their

knowledge of the proceedings.
